1.) What is your vision for the future of downtown Elgin, and how do you see it contributing to the overall growth of the city?

2.) What specific steps would you take to support local businesses in downtown Elgin?

According to the DNA annual report it stated there are "445 Total Business units operating in downtown Elgin as of January 2023." These businesses are critical to Elgin's economic growth.

To support local businesses in downtown Elgin and to strengthen this critical business ecosystem, I would take the following steps:

- Create 'Local Businesses TA Day', in which on these days we would have a coalition of business supporting organizations come together to provide at no cost technical assistance to businesses directly in downtown Elgin. These events would offer guidance on accessing funding, optimizing operations, and implementing growth strategies directly addressing the business turnover concerns highlighted in the Main Street America Transformation Strategy report.
 - Develop a streamlined system connecting local businesses to no-cost opportunities they may otherwise miss - including private grant opportunities, tax preparation assistance, bookkeeping tools, and information available storefronts. This proactive approach ensures our local entrepreneurs have every advantage to thrive.
 - Launch a targeted campaign to redirect local spending back into downtown. The Elgin Development Group's 2021 Retail Market Analysis revealed \$240 million in resident spending going outside our community. This initiative would highlight unique downtown offerings and demonstrate how local spending strengthens our entire community.
- Partner with social service organizations and city staff to implement compassionate, effective approaches to addressing those confronting homelessness downtown - addressing a key concern identified by survey respondents in the Main Street America report while supporting our most vulnerable residents.

3.) How would you involve residents, business owners, and other stakeholders in decisions impacting downtown Elgin?

Economic development thrives when it genuinely incorporates community voices. I propose launching a pilot City Economic Development Advisory Group—a diverse coalition bringing together local business owners, workforce development experts, artists, freelancers, nonprofit leaders, representatives from the Elgin Area Chamber, D.N.A., Explore Elgin, Planning and Zoning Commission members, stay-at-home parents, union representatives, and city staff to collaboratively shape our economic future.

This pilot initiative will:

- 1. Evaluate and strengthen existing city programs, policies, and ordinances
- 2. Create strategies to increase local spending by both Elgin residents and visitors from neighboring communities
- 3. Broaden community participation in economic initiatives
- 4. Identify emerging economic challenges and develop proactive solutions

This inclusive approach harnesses our community's collective expertise and diverse perspectives. While the advisory group will focus on economic development throughout Elgin, it recognizes downtown as a critical economic engine and community hub requiring attention.

Economic development serves as the foundation for everything from infrastructure improvements to job creation and reducing those experiencing homelessness. My plan emphasizes transparency, meaningful community input, and measurable outcomes to ensure Elgin's long-term prosperity benefits all residents.

1.) What is your vision for the future of downtown Elgin, and how do you see it contributing to the overall growth of the city?

- 4. Collaborative accountability: I'll strengthen our relationship with the Downtown Neighborhood Association, which receives city funding to facilitate downtown development, to ensure they're fulfilling their contractual obligation to serve all downtown stakeholders. By reviewing their performance metrics and encouraging more inclusive programming and outreach, I'll push for accountability in how DNA represents downtown interests. As a former DNA board member, I understand both the organization's potential and its current limitations in representing our diverse downtown constituency.

I believe Elgin works best when we work together. By involving diverse stakeholders, we'll develop more creative solutions and build broader support for downtown initiatives, leading to more successful and sustainable outcomes.
